<b>3 Purpose of handling personal information</b>	<p>The purpose of handling personal information is to collect the necessary information required by the Associations Act's (503/1989) 11§ and other information necessary for the association's activities.</p> <p>The member register is held electronically in Kide.app and Google Drive</p> <p>Information collected for the association's other activity (events) that the participant has voluntarily given will be held in Google Drive until they are no longer needed for the purpose of organizing the event.</p>
<b>4 Information saved to the register</b>	<p>Personal information required by the Association Act's (503/1989) 11§ (member's name and home municipality) will be collected in the register.</p> <p>Information collected for the association's other activities are those relevant to the organization of events (eg. name, phone number, email address, subject association/guild, food allergies)</p>
<b>5 Storage of information</b>	<p>Information stored in the register will be held as long as the person is a member of Pelletti ry. Outdated information will be deleted after 180 days of the end of membership. Pelletti ry's membership can be resigned by informing the board or its chairperson in writing, or by informing of the resignation to the minutes of the association's meeting.</p> <p>Information collected for the association's other activity will only be held for as long as is necessary to carry out that activity.</p>
<b>6 Transfer of information</b>	<p>Collected personal information will not be transferred to systems or persons outside of those mentioned in this document.</p>
<b>7 Protection of information</b>	<p>Personal information will be held confidentially. Only Pelletti ry's board and committee members have access to the register, who will protect privacy and security to the best of their ability.</p>



<b>8</b> <b>Cookies</b>	Pelletti ry uses cookies on its website to provide web services. Cookies will identify the user and allow features such as setting site profiles automatically based on previous visits. Cookies can be blocked partially or fully from a web browser's security settings, but it can lead to the login systems of many websites not functioning and to worse quality of service.
